Carol updated Convention numbers: 111 PAs 38 Deputies 80 Vendors

Rhonda gave the treasurer's report for total assets in all banking accounts of \$72,975.37 (See attached report). Motion to accept by Danielle Boggs, 2nd from Chrissy Welch. Motion carries. The audit committee will need the information to give their report on Friday. Lisa Ashbury is the chair for that committee.

Amanda reported that this year has been a little overwhelming just being public administrator let alone serving as president. A group of Public Administrators presented at NGA which was super exciting and have been accepted to present again on the big stage with Janet Thompson, a Judge in Michigan with Amanda & Karen Digh-Allen. NGA was very eye opening and is being held in Dallas this year. Virtual Lunch and Learns have been taking place most months and that is such a bonus to our association. Amanda was able to attend all but region 4's trainings and is hoping to go as past president next year as Danielle will already be there. It has been such a pleasure to be able to attend those meetings to see how everyone does things.

Danielle's VP report- Went to NGA in October and attended Reg 4 meeting.
